SPEECH AND LANGUAGE SERVICES CONTRACT

THIS CONTRACT, Made this 3 day of ______, 2019 by and between ROANE COUNTY BOARD OF EDUCATION (hereinafter called the "Board") and LINGUACARE ASSOCIATES, INC., a general practice, with offices located at 120 Hanworth Lane, Daniels WV 25832 (hereinafter called the "Contractor").

RECITALS

- Contractor is comprised of Vickie H. Pullins and Jacqueline Frazier, and associates, doing business as LinguaCare Associates, Inc., who hold Certificates of Clinical Competence issued by the American Speech and Hearing Association and licensed by the State of West Virginia enter into this agreement with Board as an independent contractor.
- 2. The Board desires to furnish certain services including, but not limited to, screenings, evaluations, speech-language therapy, placement meetings, annual and triennial reviews, and consultative services to the schools under its jurisdiction in ROANE COUNTY, West Virginia and Contractor agrees to perform all such duties as Speech-Language Pathologists in order to completely fulfill the purposes of this Contract.

NOW THEREFORE, for the reasons contained in the above recitals and in consideration of the mutual covenants set forth herein, Board and Contractor agree as follows:

- 3. This contract shall become effective on August 1, 2019 for a period of 12 months ending on the last day of the school term 2019-2020.
- 4. Contractor shall perform all of its duties as Speech-Language Pathologists and shall observe and enforce all county, state and federal statutes, rules, regulations and policies relating to that position. To insure quality of services if Contractor provides services to one school in a day the maximum caseload will be 25 students, however, if Contractor must travel to more than one school in a day the maximum caseload will be 20 students.
- 5. Board agrees to pay Contractor for its services at the rate of forty-two dollars per 30 minute session with a guarantee of six sessions per day.
- Contractor agrees to provide Board with a written monthly invoice for its services which shall be mailed to the Board not later that the fifth day of the month following the month of the rendering of its services. Board agrees to make payment in full to Contractor for such services as set forth

in the written invoice by the twenty-fifth day of the month following the month of service.

- 7. Contractor agrees to provide the Board with written documentation for all therapy services rendered, of evaluations, progress and discharge as required by federal and state laws and policies of Board.
- 8. This contract may be terminated by either party upon written notification to the other made not less than thirty (30) days prior to termination.
- 9. This contract shall be binding upon the heirs, devisees, personal representatives, successors and assigns of Board and Contractor.
