

September 10, 2020 Surplus Personnel Reassignments

Due to changes in enrollment unforeseen prior to May 1, per WVBE Policy 5000, a number of reassignments is proposed to meet the need for teachers of students engaged in Distance Learning. All figures as reported by schools as of Thursday, September 10, 2020, at 4:30 pm.

Kindergarten

Geary: 10 distance, 12 in-person; one teacher currently assigned
Spencer: 27 distance, 39 in-person; three teachers currently assigned
Walton: 14 distance, 14 in-person; one teacher currently assigned

Recommendation

Reassign 1 teacher at SES to distance learning (no BOE action required), create 1 new position at Walton and 1 new position Countywide based at Spencer for distance learning

Resulting class sizes

Geary in-person: 12
Walton in-person: 14
Spencer in-person: 19, 20
Spencer distance: 23
Walton distance: 14
Countywide distance: 14 (10 Geary + 4 Spencer)

1st Grade

Geary: 8 distance, 8 in-person; one teacher currently assigned
Spencer: 36 distance, 37 in-person; four teachers currently assigned
Walton: 11 distance, 12 in-person; one teacher and one vacancy currently assigned

Recommendation

Reassign 1 teacher at SES to distance learning (no BOE action required), reassign vacancy position at Walton to Countywide based at Walton for distance learning, and create 1 new position at Spencer for 1st / 2nd distance learning

Spencer distance: 25
Countywide based at Walton distance: 19 (8 Geary + 11 Walton)
Spencer 1st/2nd distance: 29 (11 1st + 18 2nd)

2nd Grade

Geary: 11 distance, 7 in-person; one teacher currently assigned

Spencer: 43 distance, 36 in-person; four teachers currently assigned

Walton: 15 distance, 16 in-person; two teachers currently assigned

Recommendation

Reassign 1 teacher at SES to distance learning (no BOE action required), reassign 1 teacher at Walton to Countywide based at Walton for distance learning, and create 1 new position at Spencer for 1st / 2nd distance learning

Resulting class sizes

Walton in-person: 16

Spencer in-person: 12, 12, 12

Spencer distance: 25

Countywide based at Walton distance: 26 (11 Geary + 15 Walton)

Spencer 1st/2nd distance: 29 (11 1st + 18 2nd)

3rd Grade

Geary: 18 distance, 12 in-person; two teachers currently assigned

Spencer: 47 distance, 32 in-person; four teachers currently assigned

Walton: 12 distance, 17 in-person; one teacher and one 3rd / 4th teacher currently assigned

Recommendation

Reassign 1 teacher at SES and 1 teacher at Geary to distance learning (no BOE action required), reassign surplus 6th Grade position at Geary to 3rd Grade Countywide based at Geary, and reassign 1 teacher at Spencer at distance learning for 3rd/4th (BOE action pending September 25 due to timeline)

Countywide based at Geary distance: 21 (12 Walton + 9 Spencer)

4th Grade

Geary: 6 distance, 10 in-person; two teachers currently assigned

Spencer: 34 distance, 37 in-person; four teachers currently assigned

Walton: 13 distance, 15 in-person; one teacher and one vacancy currently assigned

Recommendation

Reassign 1 teacher at SES to distance learning (no BOE action required), reassign 1 teacher at Geary to Countywide based at Geary for distance learning, and create 1 new position at Spencer for 1st / 2nd distance learning

Resulting class sizes

Geary in-person: 10

Walton in-person: 11, 11, 10 (3rd and 4th)

Spencer in-person: 12, 12, 13

Spencer distance: 28

Countywide based at Geary distance: 19 (6 Geary + 13 Walton)

Spencer 3rd / 4th distance: 19 (13 3rd + 6 4th)

5th Grade

Geary: 18 distance, 11 in-person; two teachers currently assigned

Spencer: 37 distance, 45 in-person; four teachers currently assigned

Walton: 12 distance, 13 in-person; one teacher and one vacancy currently assigned

Recommendation

Reassign 1 teacher at SMS and 1 teacher at Geary to distance learning (no BOE action required) and reassign vacancy at Walton to Countywide based at Walton for distance learning

Resulting class sizes

Geary in-person: 11

Walton in-person: 13

Spencer in-person: 15, 15, 15

Spencer distance: 28

Geary distance: 18

Countywide based at Walton distance: 21 (12 Walton + 9 Spencer)
